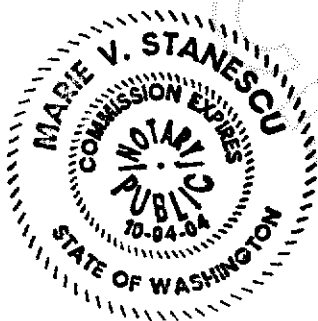



## EXHIBIT "A"

### Parcel A:

Lot 1 and the North 5 ½ feet of Lot 2, Block 290, JULIUS S. POTTER'S PLAT OF FIDALGO CITY, according to the plat thereof recorded in Volume 2 of Plats, page 77, records of Skagit County, Washington;

TOGETHER WITH the South 35 feet of Cullum Street, as vacated by Skagit County Order entered in Volume 19 of Commissioners Records, page 151 under Resolution 5980, lying East of the center line of vacated alley in said Block 290, extended Northerly, and West of the West line of Lexington Avenue as would attach by operation of law;

ALSO TOGETHER WITH all that portion of the South Half of Cullum Street, as vacated by Skagit County, August 25, 1952 under Resolution 8814, lying East of the Easterly line of the alley, extended Northerly, in Block 290, as would attach by operation of law;
