AGREEMENT AND EASEMENT

GRANTOR: Leola Robinson

GRANTEE: Racanello Construction Co.

ABBREVIATED LEGAL DESCRIPTION: Lots 13, 14 and a portion of Lot 15,

The Grantor, Leola Robinson, a single person, for consideration of \$1.00 (One Dollar) in hand paid and other valuable consideration, does by these presents convey to Racanello Construction Co., a Washington corporation, the following easement:

A perpetual non-exclusive easement for ingress, egress and utilities over, under and across twenty (20) feet west of the center line of vacated Sunrise Street, and thus north for a distance of 254 feet along said vacated Sunrise Street, making a rectangular easement 254 feet long in a north-south direction and 20 feet wide in an east-west direction lying ten (10) feet east of Lots 13, 14 and 15 of "KALLESTROM'S VIEW MOOR PLAT" of Skagit County, Washington as recorded in Volume 8 of Plats, page 8, records of Skagit County.

Said easement is for the benefit of real property in Skagit County, Washington, legally described as follows:

It is further agreed that if road improvements or utilities placement are commenced for the sole benefit of one property, that property owner shall be liable for the cost and expense incurred; provided, that rules regarding participation and

latecomers' fees customary in Utility Local Improvement Districts under Chapter 36.94 RCW, shall be imposed on those lots which benefit from utility or road improvements.

It is further agreed that, should any of the Lots benefit from the use of the road for ingress and egress, those Lots shall be subject to assessments for maintenance of the road, as well as latecomers fees for installation.
