The sale will be made without warranty, express or implied regarding title, possession, or encumbrances on 05/31/2002. 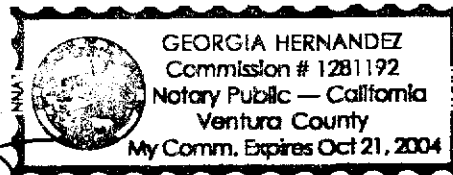
