**MEMORANDUM OF UNDERSTANDING REGARDING TIMBER SALE

The purpose of this agreement is:

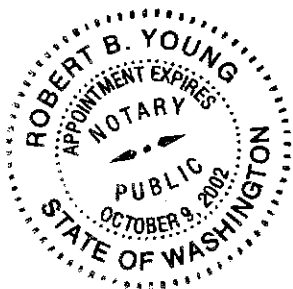

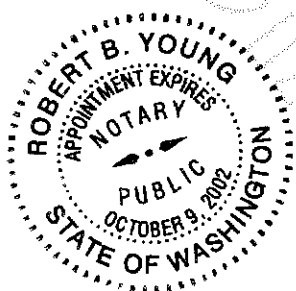
