That portion of Government Lot 9, Section 19, Township 34 North, Range 4 East, W.M., described as follows:

Beginning at a point 645.9 feet South (South 1 degree 26'44" East for this description) and 471.32 feet West (South 88 degrees 33'16" West for this description) of the Northeast corner of said Section 19, said point being on the West line of First Street, as established in the City of Mount Vernon, Washington;
thence North 1 degree 26'44" West 30.00 feet along the West margin of said First Street;
thence South 88 degrees 33'16" West 70.00 feet;
thence North 1 degree 26'44" West 20.00 feet;
thence North 37 degrees 54'53" West 29.84 feet;
thence South 88 degrees 33'16" West 15.26 feet;
thence North 1 degree 26'44" West 18.00 feet;
thence South 88 degrees 33'16" West 66.94 feet to the East line of the Burlington Northern Railroad (formerly Great Northern Railroad) right of way;
thence Southwesterly along a curve to the left having an initial tangent bearing of South 13 degrees 48'31" West, a radius of 1,452.07 feet, through a central angle of 3 degrees 43'56", and arc distance of 94.59 feet to a point which bears South 88 degrees 33'16" West from the point of beginning;
thence North 88 degrees 33'16" East 191.84 feet to the point of beginning.
