
The undersigned as property owners of land in the below-described Skagit County short plat do hereby consent and agree to the removal of those notes from the face of said short plat which state as follows:

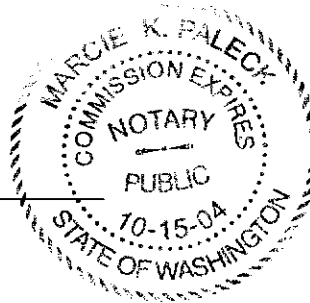

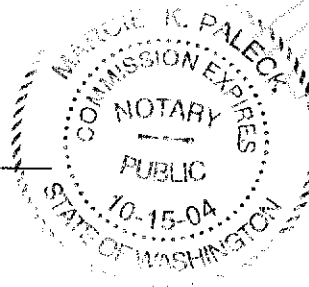

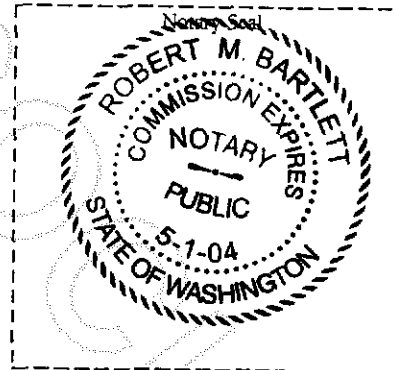
