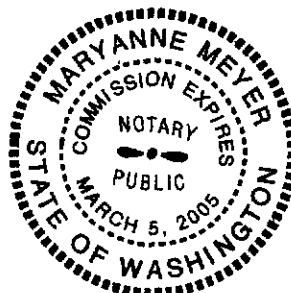


EXHIBIT "A"

PARCEL B:
