MEMORANDUM OF OPTION

This is a Memorandum of a certain Option Agreement between Charles I. Stavig as seller ("Seller"), and The Trust for Public Land, a California nonprofit public benefit corporation as buyer ("Buyer") dated as of October 26, 2001 (the "Option Agreement"). By said Option Agreement, Seller has granted to Buyer an exclusive Option to purchase that certain real property located in Skagit County, Washington, described as follows:

The Southwest Quarter of the Northeast Quarter of the Southwest Quarter (SW1/4 NE1/4 SW1/4) of Section 13, Township 34 North, Range 1 East, W.M., and the Northwest Quarter of the Southeast Quarter of the Southwest Quarter (NW1/4 SE1/4 SW1/4) of said Section 13;

TOGETHER WITH the North Half of the Southwest Quarter of the Southeast Quarter of the Southwest Quarter (N1/2 SW1/4 SE1/4 SW1/4) of Section 13, Township 34 North, Range 1 East, W.M.;

EXCEPT the South 730 feet thereof.

Said Option expires six (6) months from its Effective Date, and may be extended as provided for therein.
