Amendment to Second Declaration of  
Covenants, Conditions and Restrictions

WHEREAS, the undersigned, being all of the lot owners of certain land situated in the County of Skagit, State of Washington, known as Signe Place and described in Appendix "A" attached hereto, are in unanimous agreement to the following amendment to the aforementioned Second Declaration of Covenants, Conditions, Easements and Restrictions;

NOW, THEREFORE, Section 2.6 of said Second Declaration of Covenants, Conditions, Easements and Restrictions for Signe Place shall be deleted with the following provision inserted in its place:

"2.6 Fences and Hedges. Side yard fences shall not project beyond the front walls of any dwelling or garage except at entry as installed by developer. No chain link fencing may be used. Hedges or other solid screen planting may be used as lot line barriers. Retaining walls: Nothing shall prevent the erection of a necessary retaining wall, the top of which does not extend more than two feet above the finished grade at the back of said wall."

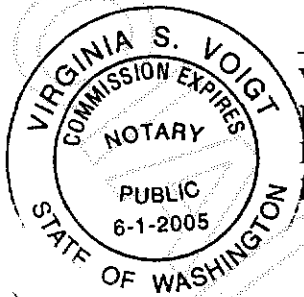

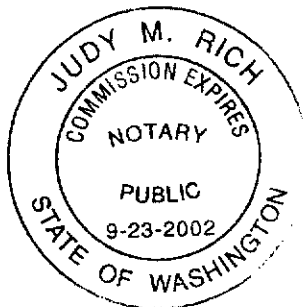

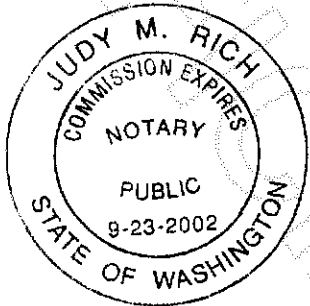
