## AMENDMENT OF DEED OF TRUST

This Amendment of Deed of Trust is entered into on May 1, 2002, between ANACORTES, L.L.C. ("Grantor"), and U.S. BANK NATIONAL ASSOCIATION ("U.S. Bank").

## RECITALS

- A. Grantor granted U.S. Bank a deed of trust dated April 30, 1998, which was recorded on April 30, 1998, in the records of Skagit County, Washington, as document no. 9804300129. That document, as subsequently amended, is referred to below as the "Deed of Trust."
- B. The Deed of Trust encumbers the real property described in attached Exhibit A (the "Real Property").
- C. The Deed of Trust was given to secure certain indebtedness described more particularly in the Deed of Trust. Grantor, among others, have requested certain modifications of such indebtedness. Grantor and U.S. Bank wish to amend the Deed of Trust to reflect their agreement that the lien created by the Deed of Trust in favor of U.S. Bank secures such modified indebtedness (and all modifications, amendments, and renewals thereof).

- 2. Grantor and U.S. Bank hereby confirm that references to the "Loan Agreement" in the Deed of Trust shall be references to the Amended and Restated Loan Agreement among Grantor, U.S. Bank, and others dated May 1, 2002, as such agreement may be modified from time to time.
- 3. All other terms and conditions of the Deed of Trust shall remain in full force and effect. This first amendment shall have no effect upon the priority of the lien created by the Deed of Trust.
