

in Skagit County, Washington, have been sold and all rights transferred to NWP as of the effective date of the above referenced Timber Sale Agreement.





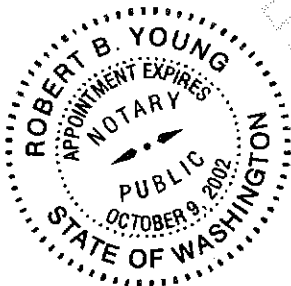
