AMENDMENT TO RIGHT-OF-WAY and EASEMENT CONTRACT

This Right-of-Way Contract Amendment (“Amendment”) is dated this 21st day of June, 2002, by and between **NORTHWEST PIPELINE CORPORATION**, located at **295 Chipeta Way, P.O. Box 58900, Salt Lake City, Utah 84158-0900** (“Grantee”), successor-in-interest to El Paso Natural Gas Company and **Greg Jeffrey Gilbertson** (“Grantor”) whose address is **Box 1724, Stanwood, WA 98292**.

RECITALS:

WHEREAS by that certain Right-of-Way Contract dated **April 6, 1956** (the “Contract”), recorded in the records of **Skagit** County, Washington, Volume **281**, Page **96**, as Grantors predecessors-in-interest, granted and conveyed unto Grantee’s predecessor-in-interest a right-of-way on, over and through certain real property situated in **Skagit** County, State of **Washington**, as described and identified in the Contract.

And by that certain Amendment dated **April, 20, 1970** (the “Amendment”), recorded in the records of **Skagit** County, Washington, Volume **46**, Pages **687-689**, as Grantors predecessors-in-interest, granted and conveyed unto Grantee’s predecessor-in-interest a right-of-way on, over and through certain real property situated in **Skagit** County, State of Washington, as described and identified in the Contract.

WHEREAS the undersigned Grantor warrants that it is now the owner in fee simple of the described property or a portion of the property as of the amendment date. The Grantors now own that portion of the property known as Assessor Parcel Number **P18117** being in Section **17**, Township **33N**, Range **05E**, **Skagit** County, Washington.

AGREEMENT:

NOW THEREFORE, for and in consideration of the mutual promises contained in this Amendment, Grantor grants to Grantee an amendment as described below:

The parties desire and agree to amend the Contract(s) to allow for the installation and construction of the grantees proposed 36 inch pipeline and to specify the location of the easement as follows.


1. The Right-of-Way shall be 75 feet in Width over a portion of Skagit County Assessor Parcel Number **P18117** being 20 feet (more or less) westerly and 55 feet (more or less) easterly, as measured from Grantee's westerly most pipeline.
2. Said Right-of-way shall be limited to three pipelines. Construction Requirements for installation of the Grantees 36 inch pipeline are shown on the attached exhibit "A".

This Amendment shall be binding upon and inure to the benefit of the heirs, successors and assigns of the parties to this Amendment.

Except as amended, all terms, conditions and provisions of the existing Right-of-Way Contract(s) and Amendments thereto shall remain and continue in full force and effect.







EXHIBIT "A"

CONSTRUCTION STIPULATIONS AGREEMENT

In accordance with the terms and conditions of the Easement, the Grantor and Grantee agree that the natural gas pipeline facilities will be constructed on Grantor's property in accordance with the following terms and conditions:

1. There shall be no additional above ground appurtenances, except for cathodic protection, and pipeline markers as required by law.
2. Payment includes all reasonable and customary damages.
3. Easement and TWS shall be returned to same approximate grade and all stumps will be ground to at least 6 inches under grade.
4. Grantee agrees to provide an as built survey within 180 days of completion of 3rd pipe installation.
