Tract 1: All that portion of the hereinafter described PARCEL "A" lying within a tract of land beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 229+75 on the SR 538 line survey of SR 538, Mt. Vernon Vicinity, and 30 feet northeasterly therefrom; thence northeasterly to a point opposite said HES 229+75 and 55 feet northeasterly therefrom; thence southwesterly parallel with said line survey to a point opposite HES 229+90 thereon; thence southwesterly to a point opposite said HES 229+90 and 30 feet northeasterly therefrom; thence northwesterly to the point of beginning.

Tract 2: All that portion of the hereinafter described PARCEL "A" lying within a tract of land beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) 230+10 on the SR 538 line survey of SR 538, Mt. Vernon Vicinity, and 30 feet northeasterly therefrom; thence northeasterly to a point opposite said HES 230+10 and 55 feet northeasterly therefrom; thence southwesterly parallel with said line survey to a point opposite HES 230+25 thereon; thence southwesterly to a point opposite said HES 230+25 and 30 feet northeasterly therefrom; thence northwesterly to the point of beginning.

The northeast quarter of the southeast quarter of Section 15, Township 34 North, Range 4 East, W.M., lying northerly of that right-of-way of State Highway No. 538, as delineated on Washington State Highway Map No. 292, Book 89, File 151, Sheet #2, dated June 1919, more commonly known as College Way;
