

SECOND AMEMDMENT TO DECLARATION SUBMITTING PROPERTY TO THE WASHINGTON HORIZONTAL PROPERTY REGIMES ACT FOR "SKYLINE MARINE CONDOMINIUM"

The undersigned, as an authorized officer of the "Skyline Marine Owner's Association – Condominium No. 17, " a Washington Association, does hereby amend that certain Condominium Declaration previously filed herein on July 23, 1970 under Skagit County Auditor's File No. 741481 in Volume 49 of Plats, pages 363 to 376 and which was filed coincident with a Survey Map filed under Skagit County Auditor's File No. 741482 in Volume 49 of Plats, pages 377 and 378 and a set of plans filed under Skagit County Auditor's No. 741483 in Volume 49, page 379 as follow:

- 1. Section 15, captioned: COLLECTION OF ASSESSMENTS

 AND SECURITY DEPOSITS: beginning at the end of line 6, to
 wit: require such owner from time to time to make a security
 deposit not to exceed three months estimated monthly assessments
 is changed to read the most recent semi-annual assessment.
- 2. That except as noted above, all other matters set forth in the original Declaration and the previous amendments thereto for said condominium are unchanged and remain in full force and effect.



The above amendments have been consented to by more than 60% of the owners of the units within the condominium by a mailed ballot of all of the owners prior to the last annual meeting in May of 2002.
