Peters Road No. 263 Extension, by Deeds recorded October 5, 1920, May 19, 1947, May 26, 1947, and September 9, 1947, under Auditor's File Nos. 145101, 404833, and 408561, respectively, TOGETHER WITH that vacated portion of Garden Drive which by law has reverted to said premises.

TOGETHER WITH a non-exclusive easement for ingress, egress and utilities, over, under, across and through the existing driveway access running across Tracts 45 and 46, of said Plat as the same existed on September 17, 1982, as reserved by document recorded September 22, 1982, under Auditor's File No. 8209220011, records of Skagit County, Washington.


