A. BACKGROUND

1. A Hearing was held on February 13, 2002 before Bradford E. Furlong, Hearing Examiner *Pro Tem* for Annual Review of Conditional Use Permit CU 75 0233. Witnesses gave testimony and exhibits were presented in this matter. On April 23, 2002 Hearing Examiner *Pro Tem* Furlong issued Findings of Fact, Conclusions of Law and Decision and Order.
2. The Washington Department of Natural Resources (DNR) appealed the Order to the Skagit County Board of Commissioners.
3. The Board of County Commissioners deliberated on this matter on July 1, 2002 and issued Resolution R20020228 on July 2, 2002, instructing the Hearing Examiner to vacate his decision and remand the matter to the Administrative Official for determination and further proceedings as necessary.

B. ORDER

Based on the foregoing it is **HEREBY ORDERED THAT:**

The Findings of Fact, Conclusions of Law and Decision and Order dated April 23, 2002 is hereby vacated and this matter remanded to the Administrative Official for determination as to whether the two (2) conditions of CU 75-0233 have been satisfied and for further proceedings as necessary consistent with Resolution R20020228.
