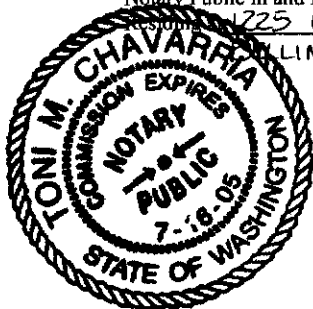

Beginning at the intersection of the West line of the Southwest Quarter of the Northeast Quarter of said Section 8, with the North line of the South Half of the South Half of the North Half of said Southwest Quarter of the Northeast Quarter of said Section 8;

Thence running North  $88^{\circ}10'46''$  West along said North line 42.45 feet;

Thence South  $00^{\circ}28'55''$  East, 243.09 feet;

Thence South  $88^{\circ}04'23''$  East to the West line of said Southwest Quarter of the Northeast Quarter and the true point of beginning;

Thence continuing South  $88^{\circ}04'23''$  East to the West margin of Alger Cain Lake Road;

Thence South  $38^{\circ}26'08''$  West along said West margin of road 201.73 feet to the West line of said Southwest Quarter of the Northeast Quarter;

Thence running North along said West line to the true point of beginning.
