EASEMENT AGREEMENT


WHEREIN, Grantor, for valuable consideration, the receipt of which is hereby acknowledged, hereby grants, bargains, sells, and conveys to Grantee and to its successors and assigns a perpetual easement and right to enter upon the following described property of the Grantor situated in the County of Skagit, State of Washington:

The area (~~P20760~~) located North of the 3rd Street right-of-way and South of "Tract B" (P20801), Snee-Oosh, according to the plat thereof recorded in Volume 4, page 50, records of Skagit County.


The Grantor does hereby grant, bargain, sell and convey unto the Grantee a right-of-way and easement for utility lines together with the right to construct, maintain, and operate said utility lines and their necessary appurtenances in, upon, through and across the above described property.

The Grantee shall have the right to enter upon said property at such times as may be necessary for the purposes of constructing, repairing or operating said utility lines or making any connection therewith without prior legal proceedings and without incurring any liability thereof. In the event that the private and permanent improvements existing in the above described right-of-way are disturbed or damaged during the construction or maintenance of said water lines, the Grantee shall replace said improvements in as good a condition as they were immediately before the property was entered upon.

This easement shall be a covenant running with the land and shall be binding upon the Grantor and its heirs and assigns forever.


