THIS SUBORDINATION AGREEMENT is made this 10th day of September 2002, by and between Capital One, FSB (hereinafter "Capital One") Greenpoint Mortgage Funding, Inc.. (hereinafter "mortgagee"). Said Deed of Trust was recorded under Auditor's File No.

200204300095, Skagit County, Washington.
Shannon Palmer ("Borrower") executed and delivered to Capital One a mortgage or deed of trust in the sum of \$5000.00 and recorded August 14, 2001 in the Instrument number 200108140011, in the records of Denver county, which mortgage or deed of trust is a lien on the following described property:

ALL THAT CERTAIN TRACT OR PARCEL OF LAND SITUATE IN SKAGIT COUNTY, WASHINGTON, KNOWN AS BEING LOTS 19 AD 20, BLOCK 69, "AMENDED PLAT OF BURLINGTON, SKAGIT COUNTY, WASHINGTON" AS PER PLAT RECORDED IN VOLUME 3 OF PLATS, PAGE 17, RECORDS OF SKAGIT COUNTY, WASHINGTON.

WHEREAS, Mortgagee is making a mortgage loan on or about this date to Borrower encumbering the same real property described in the Legal Description above.

WHEREAS, Mortgagee is willing to make such loan to Borrower provided that Capital One unconditionally subordinates the lien of its mortgage or deed of trust to the lien in favor of Mortgagee.

WHEREAS, Capital One has agreed to subordinate to Mortgagee on the following conditions:

1. Subordination of Lien: Capital One hereby subordinates its lien position in and on the property to Mortgagee's mortgage or deed of trust and the lien itself thereof, as if Mortgagee's mortgage or deed of trust had been recorded first in time to Capital One, and so that all public records will reflect Mortgagee's mortgage or deed of trust to be superior in lien to the mortgage or deed of trust of Capital One.

2. This subordination shall be binding upon and inure to the benefit of the respective heirs, successors, and assigns of borrower and lender.
