- L. An Amendment to the Covenants dated January 28, 2002 was recorded on August 10, 2001 under Auditor's File No. 200201310042, records of Skagit County, Washington ("the Amendment to Covenants").
- M. The original Covenants and the Amendment to Covenants are collectively referred to hereinafter as "the Covenants."
- N. The Covenants authorize amendment upon the affirmative vote or written consent of at least two-thirds of the owners and the consent of the Declarant until such time as the Declarant has sold all of the Lots.
- O. The undersigned owners of platted lots in the Plat constitute at least two-thirds of the owners of all lots in the Plat and wish to amend the Covenants to increase the minimum size of dwellings constructed on each lot from 1,500 to 1,800 square feet, as initially established in the Original Covenants.

SECOND AMENDMENT TO RESTRICTIONS AND COVENANTS OF PLAT

NOW, THEREFORE, the undersigned record owners of the lots located within the Plat hereby agree to amend the Covenants as follows:

- Section 1. Subsection 2.3.2 of the Covenants shall be amended in is entirety and as amended shall read as follows:
 - 2.3.2. Minimum Area. Unless a variance is granted, residential units, all of which are single family dwellings, shall not be less than 1,800 square feet without specific approval of the ACC for good cause.
- Section 2. It is understood and agreed by each of the undersigned owners of lots within the Plat that the amendment contemplated by this instrument shall be effective only upon its execution by at least two-thirds of the owners of all lots located within the Plat and the signed Consent of the Declarant.
- Section 3. This Amendment shall not cause any other provision of the Covenants to be modified.
- Section 4. By executing this Amendment to Declaration, LRDTD hereby evidences its consent as the Declarant to this Amendment.
