## LEGAL DESCRIPTION:

# PARCEL "A":

That portion of Government Lot 2 in Section 19, Township 35 North, Range 2 East W.M., described as follows:

Beginning at the intersection of the East line of Commercial Avenue with the South line of Nineteenth Street produced, in the City of Anacortes; thence East 90 feet; thence North 140 feet; thence West 90 feet; thence South 140 feet to the point of beginning.

## PARCEL "B":

That portion of Government Lot 2 in Section 19, Township 35 North, Range 2 East W.M., described as follows:

Beginning at a point on the East line of Commercial Avenue in the City of Anacortes, 114 feet South of the South line of 18th Street produced East; thence South along the East line of Commercial Avenue, 42 feet to a point 140 feet North of the South line of 19th Street produced East; thence East 90 feet; thence North 42 feet to a point due East of the point of beginning; thence West 90 feet to the point of beginning.

## PARCEL "C":

That portion of Government Lot 2 in Section 19, Township 35 North, Range 2 East W.M., lying between the North and South line of 19th Street as established in the City of Anacortes, if extended, and between the East line of Commercial Avenue and the Westerly line of the right of way of the Great Northern Railway Co., EXCEPT the West 90 feet thereof.
