Commencing at the South 1/4 corner of Section 28, Township 35 North, Range 4 East, W.M.: Thence North 02°01'45" East along the West line of the Southeast 1/4 of said Section 28 a distance of 326.13 feet to an intersection with the Westerly extension of the South line of said North ½ of the West ½ of Tract 4:

Thence South 86°45'50" East along said line 30.01 feet to the Southwest corner of said North 1/2 of the West 1/2 of Tract 4;

Thence North 02°01'45" East along the West line of said Tract 4 a distance of 150.01 feet to the TRUE POINT OF BEGINNING:
