(commonly known as 3918 Mallard Point Drive, Anacortes, WA 98221), which is subject to that certain Deed of Trust, dated April 24, 2001, recorded May 9, 2001, under Auditor's File No. 200105090099 records of Skagit County, Washington, from John T. No action commenced by the Beneficiary of the Deed of Trust is now pending to seek satisfaction of the obligation in any Court by reason of the Borrower's or Grantor's default on the obligation secured by the Deed of Trust.

NOTICE TO OCCUPANTS OR TENANTS



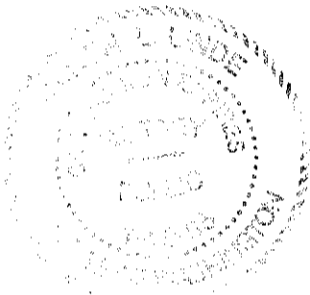


