PERSONAL REPRESENTATIVE'S DEED

- 1. GRANTOR; NONINTERVENTION POWERS. The undersigned Grantor, David Von Allmen, is the duly appointed, qualified and acting Personal Representative of the Estate of Minda Von Allmen, (the "Estate"), who died on December 13, 2001. Grantor was appointed Personal Representative of the Estate on January 16, 2002, in the Superior Court of the State of Washington for Skagit County Cause No. 02-4-00015-1 (the "Probate Proceedings"). By Order of Solvency entered on January 16, 2002 in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision.
- 2. <u>DESCRIBED COMMUNITY PROPERTY</u>. Included among the property of the Estate of Minda Von Allmen, was Minda Von Allmen's community one-half interest in the real property described as follows (the "Described Community Property"), which was community property of David Von Allmen and Minda Von Allmen at the time of the death of Minda Von Allmen:

Grantor hereby confirms and quit claims to David Von Allmen, surviving spouse of Minda Von Allmen, an undivided one-half interest in the Described Community Property, which interest represents the surviving spouse's community one-half interest in the Described Community Property.
- 4. CONVEYANCE OF DECEDENT'S COMMUNITY ONE-HALF INTEREST IN DESCRIBED COMMUNITY PROPERTY. Grantor hereby bargains, sells and conveys to **David Von Allmen**, a widower as his
