1. Short Plat number and date of approval shall be included in all deeds and contracts.

- 2. Zoning SF2/Comprehensive plan designation Sedro-Woolley Urban Growth Area.
- 3. Sewer Individual on site sewage disposal systems.
- 4. No building permit shall be issued for any residential and/or commercial structures which are not, at the time of application, determined to be within an official designated boundary of a Skagit County Fire District.
- 5. Change in location of access, may necessitate a change of address. Contact Skagit County Planning and Permit Center.
- 6. Water P.U.D. No. 1 of Skagit County.
- 7. The nearest fire hydrant is located 200 feet West of the Northwest corner of subject property at the Southwest corner of the intersection of Wicker Road and Velling Court.
- 8. A.F.#s 697064, 702790, 703764, and 717431 describe existing easements over the West 30 of the subject property. An easement for ingress, egress, and utilities over the Wets 30' in favor of Lot 3 of this short plat is hereby created. Lots 1 and 2 of this short plat may use the West 30' for utilities but may not use said West 30' for access.

In no case shall the county accept a dedication or any obligation as to any such road, street, and/or alley until the same and all roads, streets, and/or alleys connecting the same to the full, current county road system have been brought to full, current county road standards and a right-of-way deed has been transferred to and accepted by the County.
