The undersigned subordinator and owner agrees as follows:

- 1. GB Home Equity referred to herein as "subordinator", is the owner and holder of a mortgage dated August 9, 2002 which is recorded in volume under auditor's file No. 200208260135 , records of Skagit County. SIB Mortgage Corp. 2. referred to herein as "lender", is the owner and holder of a mortgage dated February 11, 2003 executed by Julie A. Stucker, as her separate property (which is recorded in volume of Mortgages, page auditor's file No 200302190123 records of County) (which Skagit is to be recorded concurrently herewith).
- 3. Julie A. Stucker, as her separate property referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4.
