THIS DEED OF TRUST, made this 27th day March, 2003,
between NO WAKE LAKES, INC., a Washington corporation,
GRANTOR, whose address is Attn: Jim Spady, Esq., 4426 - 2nd
Avenue N.E., Seattle, WA 98105, and FIRST AMERICAN

TITLE INSURANCE COMPANY, a California corporation, as TRUSTEE, whose address is 2101 Fourth
Avenue, Seattle, WA 98121, and WADE R. DANN, as his separate estate, BENEFICIARY, whose address
is 2014 E. Madison Street, Ste. 100, Seattle, Washington 98122, WITNESSETH: Grantor hereby bargains,
sells, and conveys to Trustee in trust, with power of sale, the following described real property in Skagit
County, Washington:

Lot 4, PLAT OF BOW HILL LAKE, according to the plat thereof recorded in Volume 16
of Plats, pages 224 and 225, records of Skagit County, Washington.

Assessor's Property Tax Parcel/Account Number(s): 4712-000-001-0100 and 4712-000-004-0000

which real property is not used principally for agricultural or farming purposes, together with all the
tenements, hereditaments, and appurtenances now or hereafter thereunto belonging or in anywise
appertaining, and the rents, issues, and profits thereof.

This Deed is for the purpose of securing performance of each agreement of grantor herein contained, and
payment of the sum of ONE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$175,000.00) with
interest, in accordance with the terms of a promissory note of even date herewith, payable to Beneficiary or
order, and made by Grantor, and all renewals, modifications and extensions thereof, and also such further
sums as may be advanced or loaned by Beneficiary to Grantor, or any of their successors or assigns, together
with interest thereon at such rate as shall be agreed upon, and shall be fully and unconditionally subordinated
to the deed of trust of even date in favor of Richard J. Spady & Ina Lou Spady (H&W) recorded under Skagit
County Auditor's No. 200303280222, and the deed of trust of even date in favor of Leslie A.
Dann recorded under Skagit County Auditor's No. 200303280223.

To protect the security of this Deed of Trust, Grantor covenants and agrees:


1. To pay all lawful real property taxes upon the property on or before the respective due dates, or within the thirty (30) day period thereafter with all accrued interest and penalties.
2. To defend any action or proceeding purporting to affect the security hereof or the rights or powers of Beneficiary or Trustee, and to pay all costs and expenses, including cost of title search and attorney's fees in a reasonable amount, in any such action or proceeding, and in any suit brought by Beneficiary to foreclose this Deed of Trust.
3. To pay all costs, fees, and expenses in connection with this Deed of Trust, including the expenses of the Trustee incurred in enforcing the obligation secured hereby and Trustee's and attorney's fees actually incurred, as provided by statute.
4. In the event there is a significant loss or damage to any portion of the property, Grantor agrees to commence reconstruction and/or repairs within ninety (90) days thereof.


IT IS MUTUALLY AGREED THAT:

1. All sums secured hereby shall become immediately due and payable, at the option of the Beneficiary, upon any sale by the Grantor of the property secured by this Deed of Trust.
2. In consideration of the benefits to Beneficiary from Grantor, the receipt and sufficiency of which are hereby acknowledged, Grantee does hereby unconditionally subordinate the lien of this Deed of Trust, and all advances or charges made or accruing thereunder, including any extension or renewal thereof to the liens by Deeds of Trust of even date in favor of Richard J. Spady & Ina Lou Spady (H&W) and Leslie A. Dann. Beneficiary agrees to execute whatever documents and instruments are necessary to effect the subordination provided for hereunder.
3. In the event any portion of the property is taken in an eminent domain proceeding, the entire amount of the award or such portion as may be necessary to fully satisfy the obligation secured hereby, shall be paid to Beneficiary to be applied to said obligation provided any and all superior lienholders consent thereto.
4. By accepting payment of any sum secured hereby after its due date, Beneficiary does not waive its right to require prompt payment when due of all other sums so secured or to declare default for failure to so pay.
5. The Trustee shall reconvey all or any part of the property covered by this Deed of Trust to the person entitled thereto, on written request of the Grantor and the Beneficiary, or upon satisfaction of the obligation secured and written request for reconveyance made by the Beneficiary or the person entitled thereto.
6. Upon default by Grantor in the payment of any indebtedness secured hereby or in the performance of any agreement contained herein, all sums secured hereby shall immediately become due and payable at the option of the Beneficiary if Grantor fails to cure the default within ten (10) days of receipt of the notice thereof. In such event and upon written request of Beneficiary, Trustee shall sell the trust property, in accordance with the Deed of Trust Act of the State of Washington, at public auction to the highest bidder. Any person except Trustee may bid at Trustee's sale. Trustee shall apply the proceeds of the sale as follows: (1) to the expense of the sale, including a reasonable Trustee's fee and attorney's fee; (2) to the obligation secured by this Deed of Trust; and (3) the surplus, if any, shall be distributed to the persons entitled thereto.
7. Trustee shall deliver to the purchaser at the sale its deed, without warranty, which shall convey to the purchaser the interest in the property which Grantor had or had the power to convey at the time of his execution of this Deed of Trust, and such as he may have acquired thereafter. Trustee's deed shall recite the facts showing that the sale was conducted in compliance with all the requirements of law and of this Deed of Trust, which recital shall be prima facie evidence of such compliance and conclusive evidence thereof in favor of bona fide purchaser and encumbrances for value.
8. The power of sale conferred by this Deed of Trust and by the Deed of Trust Act of the State of Washington is not an exclusive remedy; Beneficiary may cause this Deed of Trust to be foreclosed as a mortgage.
9. In the event of the death, incapacity, disability or resignation of Trustee, Beneficiary may appoint in writing a successor trustee, and upon the recording of such appointment in the mortgage records of the county in which this Deed of Trust is recorded, the successor trustee shall be vested with all powers of the original trustee. The trustee is not obligated to notify any party hereto of pending sale under any other Deed of Trust or of any action or proceeding in which Grantor, Trustee, or Beneficiary shall be a party unless such action or proceeding is brought by the Trustee.
10. This Deed of Trust applies to, inures to the benefit of, and is binding not only on the parties hereto, but on their heirs, devisees, legatees, administrators, executors, and assigns. The term Beneficiary shall mean the holder and owner of the note secured hereby, whether or not named as Beneficiary herein.


