AGREEMENT BETWEEN ADJOINING LANDOWNERS CREATING DRIVEWAY EASEMENT

This is a mutual and reciprocal easement entered into this day of April, 2003, between ROGER R. JUNGQUIST and LESLIE C. JUNGQUIST, husband and wife, and ROBERT K. JUNGQUIST and GINA MARIE JUNGQUIST, husband and wife, hereinafter called "JUNGQUIST" and DARLENE YOUNGQUIST, as her separate estate, hereinafter called "YOUNGQUIST".

WHEREAS, the parties own adjoining real estate situate in Skagit County, state of Washington, described as follows:

JUNGQUIST property is described on Exhibit A
YOUNGQUIST property is described on Exhibit B

WHEREAS, the properties are adjacent to one another as depicted in Exhibit C.

WHEREAS, a driveway provides access to the Jungquist Road for each parcel of property. The exact location of the driveway is not known but it is believed to exist on both parcels of property.

WHEREAS, each desires to grant a driveway easement to the other and YOUNGQUIST desires to grant a ten (10) foot easement upon YOUNGQUIST's property along the border with the JUNGQUIST property as depicted on Exhibit C.

THEREFORE, the parties agree as follows:

1. JUNGQUIST GRANT. JUNGQUIST hereby grants an easement for ingress and egress from the Jungquist Road over and across that portion of JUNGQUIST's property presently used as and for an ingress and egress easement/access to the Jungquist Road, which easement is perpetual and appurtenant to VOUNCOUTEM's access to the season of the property of the season of the seaso

- 2. YOUNGQUIST GRANT. YOUNGQUIST hereby grants to JUNGQUIST an easement over and across that portion of YOUNGQUIST's property presently used for ingress and egress from the Jungquist Road to the Jungquist property across the YOUNGQUIST property, provided, however, in no event shall the easement across the YOUNGQUIST property be on any portion of the property which is more than ten (10) feet from the legally described boundary separating the YOUNGQUIST and JUNGQUIST properties. YOUNGQUIST in addition grants a nonexclusive perpetual and appurtenant easement to JUNGQUIST over and across the YOUNGQUIST property being ten (10) feet in width along the entire border between JUNGQUIST and YOUNGQUIST and around the building shown on Exhibit C.
- 3. MAINTENANCE OF EASEMENT. JUNGQUIST shall be responsible for all costs of maintenance of the easement and shall hold YOUNGQUIST harmless therefrom and shall keep the respective properties free of any liens for or arising out of costs of maintenance.




