PERSONAL REPRESENTATIVES' DEED

- 1. GRANTOR. The undersigned Stephen Michael Ryan (GRANTOR), is the duly appointed, qualified and acting Personal Representative of the Estate of Frank C. Ryan, Deceased.
- 2. <u>ESTATE</u>. Frank C. Ryan died on October 24, 2001. On November 6, 2001 the Will of Frank C. Ryan was admitted to probate and Grantor was appointed Personal Representative, in the State of Washington Superior Court of King County, Cause No. 01-4-05565-5 SEA (the "Probate Proceedings").
- 3. <u>NONINTERVENTION POWERS</u>. By Order entered on November 6, 2001, in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention of supervision.
- 4. <u>DESCRIBED REAL PROPERTY</u>. Included among the property of the Estate of Frank C. Ryan, Deceased, was the decedent's interest in real property located in Skagit County, Washington, described as follows (the "Described Real Property"):
 - LOT 11, Block 1, LAKE CAVANAUGH SUBDIVISION, Division No. 3, according to the plat recorded in Volume 6 of plats, pages 25 to 31 inclusive, records of Skagit County, Washington
- 5. WILL PROVISION; CONSIDERATION; NON PRO-RATA DISTRIBUTION. Article 4 of Decedent's Will directs that assets equal to the largest amount that can pass free of the estate tax be held in trust (hereinafter described as the "Frank C. Ryan Credit Trust") for the benefit of Cecelia V. Ryan. Pursuant to RCW 11.02.070, which subjects the whole of the community property to administration, and RCW 11.98.070(15), which authorizes the Personal Representative to make a non pro-rata distribution of assets Cecelia V. Ryan, for herself individually, and Stephen Michael Ryan, as Personal Representative of the Estate of Frank C. Ryan, entered into an agreement to allocate to the Frank C. Ryan Credit Trust all interest in the Described Real Property, both the one-half community property held by Cecelia V. Ryan individually, as surviving spouse, and Decedent's one-half interest.
- 6. <u>CONFIRMATION OF SURVIVING SPOUSE'S COMMUNITY ONE-HALF INTEREST IN DESCRIBED REAL PROPERTY</u>. Grantor hereby confirms and quit claims to Cecelia V. Ryan, in her capacity as Trustee of the Frank C. Ryan Credit Trust an undivided one-half interest in the Described Real Property, which interest represents surviving spouse's one-half interest in the property, which was community property to Frank C. Ryan and Cecelia V. Ryan at the time of Frank C. Ryan's death, together with all after acquired title of the Grantor therein.



- 7. CONVEYANCE OF INTEREST IN DESCRIBED REAL PROPERTY. Grantor hereby conveys and quit claims to Cecelia V. Ryan, in her capacity as Trustee of the Frank C. Ryan Credit Trust, an undivided one-half interest in the Described Real Property (together with all after acquired title of the Grantor therein), which interest represents the Decedent's one-half interest at the time of the Decedent's death.
- 8. <u>LIMITATION OF COVENANTS</u>. Grantor expressly limits the covenants of this deed to those expressed herein and excludes all covenants arising or to arise by statutory or other implication.
