## MEMORANDUM OF LEASE

THIS IS A MEMORANDUM of that certain Agricultural Lease dated the 2070 day of 1000, 2003, by and between ALICE HOFFMAN, as Trustee of the CLAUDE W. AND ALICE M. HOFFMAN LIVING TRUST and as Trustee of the CLAUDE WILLIAM HOFFMAN TESTAMENTARY EXEMPTION EQUIVALENT TRUST, as Lessor, and NORM NELSON, INC., a corporation, as Lessee for the following described real property situated in Skagit County, Washington, to wit:

All of Lot one (1), and the North one-half (1/2) of Lot Two (2), the Northwest Quarter of the Northeast Quarter and the North one-half of the Southwest Quarter of the Northeast Quarter, all in Section 18, Township 35, North, Range 3 E.W.M., in Skagit County, Washington.

Lot 5, South of Slough; Lot 6, East of Slough, Lot 7 and the SE 1/4 of the SW 1/4, all in Section 7, Township 35 North, Range 3 East of the W.M., less dike and drainage rights of way heretofore conveyed.

A parcel of land situated in Section 7, Township 35 North, Range 3, E.W.M., described as follows: Beginning where O'Keffe's slough running westerly touches the South line of the M.B. Richard warehouse lot, thence Southeasterly along the South line of said lot to an old dike, thence Southwesterly along said dikes 60 feet, thence Northwesterly to said slough, thence Northeasterly along said slough to the place of beginning.
