The amount or amounts listed does not include interest, penalties, or costs to date, and when payment is made, interest is to be computed at the rate of 12% per annum at 1% per month on the full year amount of unpaid tax. In addition, delinquent taxes are subject to penalties as follows: Three percent on the full year amount of tax unpaid on June 1<sup>st</sup> of the year in which tax is due. An additional penalty of eight percent on the amount of tax delinquent on December 1<sup>st</sup> of the year in which the tax is due.


