The portion of the proposed project which includes the 3,000 square foot storage building is located south of Chuckanut Drive, east of Avon Allen Road, at 9101 Avon Allen Road, Burlington, WA; a portion of Section 23, Township 35 North, Range 3 East, W.M., Skagit County, Washington.

John Sandell, a party of record in the permit proceedings, filed a post-hearing request with the Planning and Permit Center on May 27, 2003. The form identified the request as an appeal to the Board of County Commissioners. Through subsequent communications between County personnel and Mr. Sandell it ultimately became apparent that his intention was not to appeal but rather to request reconsideration of the Hearing Examiner's decision. The filing was timely for a Request for Reconsideration pursuant to SCC 14.06.180.

The filing has therefore been forwarded to the Examiner for his ruling on reconsideration. The request states simply that the Examiner "never addressed problems of past and future flooding." In accompanying text, it is asserted that the Examiner did not consider a historical map that was submitted into evidence.

The Examiner states that he gave the map appropriate weight but ultimately agreed with the applicant's analysis of the potential impact of this project on flood waters. He respectfully refers to Findings 10, 11, 12, 13, 14 and 15 of the May 14, 2003 decision.

Upon reconsideration, the Examiner has determined that no material legal error has occurred and that no material factual issue has been overlooked that would change the previous decision.

Therefore, the Request for Reconsideration is denied.
