PERSONAL REPRESENTATIVE'S DEED

- 1. GRANTOR; NONINTERVENTION POWERS. The undersigned Grantor, KARYN R.R. LIVINGSTON, is the duly appointed, qualified and acting Personal Representative of the Estate of RAYMOND ROSS WILSON, (the "Estate"), who died on the 1st day of November, 2001. Grantor was substituted as Personal Representative of the Estate on the 12th day of June, 2003, in the Superior Court of the State of Washington for Snohomish County Cause No. 02-4-01508-1 (the "Probate Proceedings"). By Order of Solvency entered on the 19th day of December, 2002, in the Probate Proceedings, Grantor is authorized to settle the Estate without further court intervention or supervision.
- 2. <u>DESCRIBED COMMUNITY PROPERTY</u>. Included among the property of the Estate of RAYMOND ROSS WILSON, was RAYMOND ROSS WILSON's community one-half interest in the real property described as follows (the "Described Community Property"), which was community property of RAYMOND ROSS WILSON and KARYN R.R. LIVINGSTON at the time of the death of RAYMOND ROSS WILSON:

- 4. CONVEYANCE OF DECEDENT'S COMMUNITY ONE-HALF INTEREST IN DESCRIBED COMMUNITY PROPERTY. Grantor hereby bargains, sells and conveys to KARYN R.R. LIVINGSTON, individually, an undivided one-half interest in the Described Community Property, which interest represents the Decedent's one-half interest in the Described Community Property at the time of the Decedent's death.
- 5. <u>LIMITATION OF COVENANTS</u>. Grantor expressly limits the covenants of this deed to those expressed herein and excludes all covenants arising or to arise by statutory or other implication.
