THIS SUBORDINATION AGREEMENT is made this 9th day of July, by Joan LaLonde, as her separate estate,

**WITNESSETH**

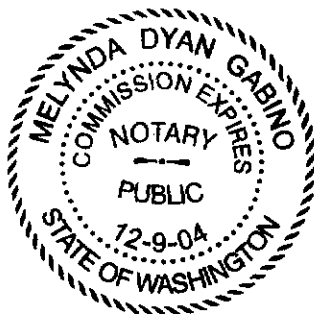
