Driveway EASEMENT

THIS AGREEMENT is by and between Mike King and Astrid King, hereafter referred to as Grantors, and Stacy Lewis, hereafter referred to as Grantee.

Said parties hereby agree as follows:

Grantors have granted, and by this instrument do convey, transfer, and deliver unto the Grantee, a permanent easement and right-of-way, including the perpetual right to enter upon the real estate hereinafter described belonging to the Grantors, at any time they may see fit, and construct, maintain, and repair, a driveway for the purpose of ingress and egress over, through, and across lands hereinafter described belonging to the Grantors, and hereby grant the further right to remove trees, bushes, undergrowth, and other obstructions interfering with the location, construction, and maintenance of said driveway and surrounding landscaping.

The easement and right-of-way hereby granted covers a strip of land owned by the Grantors and described as follows:

Southeast corner of Lot 9, Plat of Lake McMurray Estates, Mount Vernon, Washington; physical address of 21986 McMurray Shore Drive, Mount Vernon, Washington, 98274. The driveway easement measures 55 feet along the street, 35 feet from the property corner marker towards the house, and 65 feet to connect to the street, also shown on the attached site plan.

Said easement and right-of-way is granted to the Grantee and their successors and assigns forever, said easement and right-of-way being appurtenant to the following described real estate of the Grantee:

Driveway across southeast corner of Lot 9 into northeast corner of Lot 8, Plat of Lake McMurray Estates, Mount Vernon, Washington; physical address of 22100 McMurray Shore Drive, Mount Vernon, Washington, 98274.


