Easement and Agreement

This Easement and Agreement is granted and entered into this 23<sup>th</sup> day of Sytundary 2003 by and between Vincent and Linda Linnell (Linnell) and Paul G. N. deVegvar and Singteh Lu (deVegvar/Lu).

1. Grant of Easement. Linnell hereby grants to deVegvar/Lu a non-exclusive, perpetual a 10 foot wide easement for installation, repair, maintenance and

operation of a waterline over, under and through that portion of Lot 13 in the Plat of Lake McMurray Estates filed in volume 19 of Plats at Pages 55-59 and as described on the attached Exhibit "A" and Exhibit "B" which is incorporated herein situated in Skagit County, Washington, recorded June 26, 1995, recording #9506260121, for the benefit of and only of Lot 14 of this same Plat of Lake McMurray Estates.

2. Installation and Maintenance. All costs associated with the installation, maintenance, repair and operation of said water line shall be borne by then current owners of Lot 14 when such costs are incurred.


