



LEGAL DESCRIPTION FOR DIKING DISTRICT NO. 3

Diking District No. 3 Tract to Malvin L. and Erma Axthelm

That portion of the North 660 feet of Government Lot 14 of Section 36, Township 34 North, Range 3 East, W.M., described as follows:

Commencing at the Northeast corner of said Section 36, said point being marked by a 3½" diameter brass disk in monument case, said disk being marked "Wash. Co. Ref. Mark", from which bears a 1½" diameter bolt in monument case at the East ¼ corner of said Section 36, South 00°21'18" West, 2627.63 feet;
thence South 89°53'14" West, along the North line of said Government Lot 14, a distance of 670.00 feet to the Northeast corner of that certain right-of-way for dike purposes for the construction, use and maintenance of a dike as condemned by Diking District No. 3 of Skagit County in Superior Court Cause No. 2982, said point being the True Point of Beginning;
thence South 05°20'00" East, along the Easterly line of said right-of-way, 230.00 feet to an angle point thereon;
thence South 19°01'00" West along said Easterly line, 145.00 feet to a second angle point thereon;
thence South 05°45'00" West along said Easterly line, 38.12 feet to the Easterly toe of the dike as it existed in January 2001;
thence North 20°25'06" West, following said Easterly toe, 70.04 feet;
thence North 22°55'28" West, continuing to follow said Easterly toe, 96.15 feet to the Westerly line of said right of way;
thence North 19°01'00" East along said Westerly line, 34.92 feet to an angle point thereon;
thence North 05°20'00" West along said Westerly line, 139.31 feet to a second angle point thereon;
thence North 77°22'00" West along said Westerly line, 82.18 feet to a third angle point thereon;
thence North 56°27'00" West along said Westerly line, 13.75 feet to said Easterly toe;
thence North 05°57'06" West, following said Easterly toe, 0.74 feet;
thence North 17°14'16" East, continuing to follow said Easterly toe, 13.15 feet;
thence North 71°55'23" East, continuing to follow said Easterly toe, 29.88 feet;
thence North 82°28'59" East, continuing to follow said Easterly toe, 32.92 feet;
thence North 85°40'06" East, continuing to follow said Easterly toe, 10.79 feet;
thence North 11°52'41" West, continuing to follow said Easterly toe, 25.16 feet to said North line of said Government Lot 14;
thence North 89°53'14" East along said North line, 114.35 feet to the True Point of Beginning;
