3.	Megan S Messett aka Megan S Wohllenben & Chad Wohllenben, referred to herein as "owner", is
	the owner of all the real property described in the mortgage identified above in Paragraph 2.
4.	In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby
	acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in
	connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage
	identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all
	advances or charges made or accruing thereunder, including any extension or renewal thereof.

5.	"Subordinator" acknowledges that, prior to the execution hereof, he has had the opportunity to examine the
	terms of "lender's" mortgage, note and agreements relating thereto, consents to and approves same, and recognizes that "lender" has no obligation to

	mortgage in favor of "lender" above referred to and shall supercede and cancel any prior agreements as to
	such, or any, subordination including, but not limited to, those provisions, if any, contained in the mortgage
	first above mentioned, which provide for the subordination of the lien or charge thereof to a mortgage or
