EASEMENT AND AGREEMENT

THIS EASEMENT AND AGREEMENT is granted and entered into this 30th day of Sept., 2003 by and between Michael and Astrid King (the King's) and Claudia Shoemaker (Shoemaker) and Singteh Lu and Paul G. N. deVegvar (deVegvar-Lu). In consideration of ten dollars (\$10.00) and other valuable consideration, the parties hereby agree, and the King's do hereby grant an easement, as follows:

- 1. Grant of Easement. The King's hereby grant to Shoemaker and deVegvar-Lu a non-exclusive, perpetual easement for existing water wells. pumps, electric power lines, valves, and water lines, and installation, repair. operation and maintenance thereof, over, under, and across the strip of land described on the attached Exhibit A, Exhibit B, Exhibit C, Exhibit D and Exhibit E, which is incorporated herein, for the benefit of and only of Lots 14 and 15 of the Plat of Lake McMurray Estate, as per the map thereof recorded in Volume 19 of Plats, at page 55-59, Auditor's records of Skagit County, Washington, subject to the terms and provisions of this easement and agreement. Said existing wells are identified on the attached Exhibit C, which is incorporated herein, as 6" well cases for Lots 14 and 15.
- 2. Installation and Maintenance. Shoemaker and deVegvar-Lu have incurred and paid the costs of drilling and testing the wells. All costs associated with the purchase, installation, maintenance, operation and repair of said utilities for use of the wells shall be borne by the then current owners of Lots 14 and 15 when such costs are incurred. Installation of the pumps and related equipment, and all subsequent maintenance, shall be performed by a qualified technician.
- 3. Water Disclaimer. The King's make no representations or warranties concerning the quality and quantity, if any, of water that may be available from said wells, not the right to withdraw and use water from the wells.
- 4. Use Limitation. Use of the water from each well shall be for residential. domestic use only for not more than one dwelling unit and ancillary buildings. No structures, buildings, etc. relating to these wells and this easement will be allowed other than the existing 6" well cases, water meters, water valves, electrical power lines, water lines and electrical power poles.
- 5. Aesthetics. The easement and well areas shall be maintained in a neat and orderly manner, harmonious with surrounding use.
- 6. Covenant. This easement and agreement shall constitute a covenant against and shall run with the benefited and burdened lots, and be binding upon and inure to the benefit of the successors in interest to said Lots 15, 14 and 9.


