

A portion of the Northwest Quarter of the Northeast Quarter of Section 15, Township 34 North, Range 1 East of the Willamette Meridian, being also a portion of Tracts A and B, as shown on that survey record in Volume 1 of Surveys, at page 57, as Auditor's File No. 801343, records of Skagit County, Washington, described as follows:

Beginning at the Southeast corner of said Tract B;
Thence North 88°58'47" West, a distance of 73.41;
Thence North 47°23'46" West, a distance of 270.17 feet;
Thence North 89°03'22" East, a distance of 139.32 feet;
Thence North 0°56'38" West, a distance of 384.45 feet to the Southerly right-of-way line of the Biz Point county road;
Thence Easterly on a curve to the left having a radius of 984.93 feet and a central angle of 5°32'59" through an arc length of 95.40 feet to the center of a stream;
