9 **II. HEARING**

10 On November 14, 2003, the Plaintiff's Motion for entry of a Default Judgment was regularly  
11 considered by the Court. In ruling upon the motion, the court considered the Order of Default,

14 Based on the evidence presented, the Court finds that the amount claimed by the Plaintiff  
15 can be computed with certainty.

16 **IV. ORDER / JUDGMENT**


17 Based on the above Findings, the Court hereby Orders, Adjudges, and Decrees as follows:

18 1. The Plaintiff shall have and recover a final money Judgment against the Defendant  
19 Mary Kay Drill the principal sum of \$27,568.73, prejudgment interest of \$4,142.78, statutory costs  
20 of \$232.25 (consisting of \$110.00 filing fee and \$132.25 service of process costs), and reasonable  
21 attorney fees of \$1,500.00, as requested in the Complaint.

22 2. All amounts due under this final money Judgment, except for any pre-Judgment  
23 interest, shall bear interest from this date at the highest rate allowable by statute.


