## LEGAL DESCRIPTION

Lot 2 of Short Plat No. PL-02-0676, recorded October 3, 2003, under Auditor's File No. 200310030084, records of Skagit County, Washington, and being a portion of Lot 18, "WM. SHAUGER ACREAGE, CLEAR LAKE, WASH.," as per plat recorded in Volume 4 of Plats, page 36, records of Skagit County, Washington.

TOGETHER WITH a non-exclusive easement for ingress, egress and utilities over, under and across the following described tract:

Beginning at the Northeasterly most corner of said Lot 19, said point being the common corner between Lots 18 and 19 as shown in the Plat of "WM. SHAUGER ACREAGE, CLEAR LAKE, WASH.," Section 12, Township 34 North, Range 4 East, W.M., records of Skagit County, Washington, the true point of beginning; thence South 18°18'24" West a distance of 29.54 feet along the right of way of State Route 9; thence North 81°05'41" West a distance of 47.83 feet;
