All that portion of the hereinafter described PARCEL "A" lying northerly and westerly of a line beginning at a point opposite Highway Engineer's Station (hereinafter referred to as HES) A 19+31± on the A line survey of the SR 5, Mount Vernon: Blackburn St. to Skagit River and 47.39 feet easterly therefrom, said point being on the southwesterly corner of said PARCEL "A"; thence easterly to a point opposite HES A 19+33± on said A line survey and 62.17 feet easterly therefrom, said point being on the southerly line of said PARCEL "A"; thence northerly to a point opposite HES A 22+22 on said A line survey and 45.02 feet easterly therefrom and the end of this line description.
