SS ORDER VACATING COUNTY RIGHT-OF-WAY

COUNTY OF SKAGIT

In the matter of the request by

Norma Anderson,

For the vacation of a portion of unopened County right-of-way known as Coots Cove Lane.

In the matter of the vacation of a portion of County right-of-way petitioned by **Norma Anderson**, the Board finds as follows:

FIRST: That the request therefore was filed on the 7th day of October, 2003, and a \$100.00 bond was deposited.

SECOND: That an Affidavit of Sufficiency was signed on the **4th day of November, 2003**, certifying that the majority of freeholders owning property abutting the right-of-way proposed for vacation have signed the vacation petition.

THIRD: That on the 17th day of November, 2003, the County Engineer was duly directed to examine said right-of-way and make a report in writing on the same.

FOURTH: That on the 9th day of December, 2003, the County Engineer filed in the office of the Board his report on the proposed vacation in writing, as provided by law.

FIFTH: That by an order duly passed by this Board the 17th day of November, 2003, the 9th day of December, 2003, was set for hearing the report of the Engineer, and on the 15th of December, 2003, the consideration thereof, and that notice of the time and place where said hearing would be held as given by publication and posting as provided by law.

SIXTH: That said report of the County Engineer shows:

- There are other roads of equal utility for public use.
- This right-of-way is located between 2 roads and bisects the Anderson's property.
- This vacation will create more logical property boundaries.
- The right-of-way is of no benefit to the public as a County roadway and should be returned to the adjacent property owners.

and:

the Board, having examined the report of the Engineer and all other papers on file in the proceedings, and heard and considered all testimony and documentary evidence produced for and against the vacation of the road, and the Board being satisfied that said right-of-way will not be useful as a part of a general road system, and that the public will be benefited by its vacation, did unanimously vote to vacate said road right-of-way described as follows:

All that part of that certain 40 foot strip of land conveyed to Skagit County for Road purposes by Deed recorded October 5, 1920, under Auditor's File No. 145101, lying Westerly of H.C. Peters Road No. 263 extension, as conveyed to Skagit County by Deed recorded June 17, 1947, under Auditor's File No. 405657, said part being a portion of Tract 37, "BIG LAKE WATERFRONT TRACTS, SKAGIT COUNTY, WASHINGTON", as per plat recorded in Volume 4 of Plats, page 12, records of Skagit County, Washington, signed February 10, 1913, and said part being more particularly described as follows:

Beginning at the Southwest corner of said 40 foot strip of land, as said point is shown on that certain Record of Survey recorded in Book 14 of Surveys at page 196, under Auditor's File No. 9309240083, records of said County and State; thence North 25°35'51" West, along the West line of said 40 foot strip of land, 41.9 feet to the Northwest corner

thence North 78°11'56" East along the North line of said 40 foot strip of land, 28.78 feet to the Westerly line of said H.C. Peters Road No. 263 extension, said point lying on a curve to the left, the center of which bears North 35°13'21" East and is 602.96 feet distant;

thence Southerly, following said Westerly line along said curve to the left through a central angle of 00°15'20", an arc distance of 2.69 feet to the end of said curve;

thence South 55°02'00" East, continuing along said Westerly line, 23.42 feet to an angle point thereon; thence South 34°58'00" West at right angles, continuing along said Westerly line, 20.00 feet to an angle point thereon; thence South 55°02'00" East, continuing along said Westerly line, 9.99 feet to the South line of said 40 foot strip of

thence South 78°11'56" West along said South line, 29.11 feet to the point of beginning; Containing 1,319 square feet, more or less.

Situate in the County of Skagit, State of Washington.

An easement in gross is hereby reserved within the vacated right-of-way for all existing and future utilities, including extensions and improvements thereto, and recognition of any franchises of records.

It is Ordered by the Board, all the members concurring, that the County rightof-way requested to be vacated by Norma Anderson, be vacated upon payment of all costs by the principal petitioner, if any; and the clerk of the Board is directed to make a statement in writing of all costs and expenses incurred in




