## SUBORDINATION AGREEMENT

The undersigned subordinator and owner agrees as follows:

- 1. BLK Properies, LLC, a Washington limited liability company, referred to herein as "subordinator", is the owner and holder of a deed of trust dated January \_\_, 2004, which is recorded under auditor's file No. 2004 O' Crecords of Skagit County.
