The GRANTOR, **First American Title Insurance Company**, as present Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment recited below, hereby grants and conveys, without warranty, to: **Mortgage Electronic Registration Systems**, **Inc.**

- 1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between **Richard W. Lee and Mary Ann Lee**, who acquired title as Maryann Lee as Trustor in which Administrator of the Small Business Administration is named as Beneficiary and U.S. Small Business Administration as Trustee and recorded 04/10/1996 as Instrument No. 9604100036, of Official Records of Skagit County, Washington
- Said Deed of Trust was executed to secure, together with other undertakings, the payment of one
 promissory note in the sum of \$44,400.00 with interest thereon, according to the terms thereof, in
 favor of Administrator of the Small Business Administration and to secure any other sums of
 money which might become due and payable under the terms of said Deed of Trust.
- 3. The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.
- 4. Default having occurred in the obligations secured and/or covenants of the Grantor, as set forth in Notice of Trustee's Sale described below, which by the terms of the Deed of Trust make operative the power to sell, the thirty-day advance Notice of Default was transmitted to the Grantor, or his successor in interest, and a copy of said Notice was posted or served in accordance with law.

Vernon, WA, a public place, on 01/09/2004 at 10:00 a.m., and in accordance with law caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by mail to all persons entitled thereto and either posted or served prior to 90 days before the sale; further, the Trustee caused a copy of said "Notice of Trustee's Sale" to be published once between the thirty-second and twenty-eighth day before the date of sale, and once between the eleventh and seventh day before the date of sale, and further, included this Notice, which was transmitted to or served upon the Grantor or his successor in interest, a "Notice of Foreclosure" in substantially the statutory form.
- 8. During foreclosure no action was pending on an obligation secured by said Deed of Trust.
