DECLARATION OF EASEMENT
WITH JOINT MAINTENANCE PROVISIONS

This Declaration is made this 26th day of April, 1999 by Bill Brigham and Jan Brigham, husband and wife, hereinafter called Declarant.

W I T N E S S E T H :

WHEREAS, Declarant is the owner of that certain tract described on the attached Exhibit A, and

WHEREAS, Declarant has plans to subdivide the property so described into three separate parcels, and

WHEREAS, There is currently in existence a driveway/roadway from State Highway 9 to the parcels to be created, which driveway/roadway is commonly known as Brigham Lane, and

WHEREAS, Declarant wishes to establish a non-exclusive easement for ingress, egress and utilities over Brigham Lane and to establish provisions for the joint use and maintenance of the same;

NOW, THEREFORE, Declarant hereby conveys to the present and future owners of any future lot to be subdivided from the main tract described in Exhibit "A" attached hereto a non-exclusive easement for ingress, egress and utilities over, under and across the existing driveway/roadway known as Brigham Lane.

Declarant and any future owner of a portion of the property described on Exhibit "A" attached hereto hereby covenant and agree, one with the other, that all maintenance and repair of the roadway which exists for the benefit of the properties to be created, shall be shared between the present and future owners thereof, their heirs, successors and assigns, in direct proportion to their relative use of said roadway.

Declarant further covenants and agrees that should there be a disagreement as to the necessity of any maintenance or repair, each party in ownership at the time of the disagreement shall select a licensed engineer, who together will select a third licensed engineer, and they shall determine whether the disputed maintenance or repair is required to maintain the roadway in a safe and passable manner. The costs of said engineers shall be born exclusively by the non-prevailing party.

Declarant further covenants and agrees that this agreement shall be binding upon themselves, their heirs, successors and assigns and shall be a covenant running with the lands described herein.
