
And whereas the indebtedness secured, to be paid by the Deed of Trust above-mentioned has been satisfied.

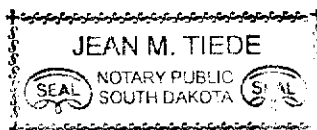


