All of these Development Agreements include the following language:

"Binding on Successors; Covenant to run With Land. This agreement is intended to protect the value of the Property, as well as the public health, safety, and welfare of the City and the benefits and burdens inuring to the Developer and to the City from this Agreement shall run with the real property described herein and shall be binding upon the Developer, and their heirs, successors, and assigns, and upon the City."

These Development Agreements also include various requirements for the construction and bonding of street improvements, plat improvements and other various obligations to be met by the developers of Sauk Mountain View Estates - South and other nearby developments. These obligations for construction and bonding should remain with the Grantor and not be passed on to future buyers of the finished lots within the various development projects.

Therefore, Grantor hereby indemnifies all future owners of the following described property
