Subordination Agreement

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- 1. MARK and JEANNE THOMPSON, husband and wife referred to herein as "subordinator", is the owner and holder of a mortgage dated January 22, 2004, which is recorded in volume of Mortgages, page , under auditor's file No. 200402340059 , records of SKAGIT County.
- 2. BANK NORTHWEST referred to herein as "lender", is the owner and holder of a mortgage dated Feburary 10,204, executed by HANSELL MITZEL LLC (which is recorded in volume of Mortgages, page , under auditor's file No. 200402240058 , records of SKAGIT County) (which is to be recorded concurrently herewith).
- 3. HANSELL MITZEL LLC referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4.
